It is alleged that you have failed to correct the violation by the required date contained in the notice of violation dated April 16, 2007, therefore;

YOU ARE HEREBY NOTIFIED that on the 26th day of April, 2007 at 2:00 P.M., a hearing will be held before the Code Enforcement Board or Special Magistrate of the City of Treasure Island, Florida at City Hall, 120 108<sup>th</sup> Avenue, Treasure Island, FL 33706, at which time you may present evidence, call witnesses, cross-examine witnesses, and be represented by an attorney.

If you do not appear at the hearing, the hearing will proceed in your absence. Further, this case may still be presented to the Code Enforcement Board or Special Magistrate at the hearing even if the violation has been corrected prior to the time of the hearing.

After the hearing, the Code Enforcement Board or Special Magistrate will make findings of facts, conclusions of law, and if a violation is found to have occurred, issue an order compelling compliance. Failure to comply with an order of the Code Enforcement Board or Special Magistrate could result in a fine of up to \$250 per day for a first time violation and up to \$500.00 per day for repeat violations, which, if assessed, could become a lien on your property.

An aggrieved party may appeal a final administrative order of the Code Enforcement Board or Special Magistrate to the circuit court. You must file any appeal within 30 days of the execution of the order to be appealed.
