It is alleged that you have failed to correct the violation by the required date contained in the notice of violation dated January 9th, 2007, therefore;

YOU ARE HEREBY NOTIFIED that on the 28th DAY OF June, 2007 at 3:00 P.M., a hearing will be held before the Code Enforcement Board or Special Magistrate of the City of Treasure Island, Florida at City Hall, 120 108th Avenue, Treasure Island, FL 33706, at which time you may present evidence, call witnesses, cross-examine witnesses, and be represented by an attorney.

If you do not appear at the hearing, the hearing will proceed in your absence. Further, this case may still be presented to the Code Enforcement Board or the Special Magistrate at the hearing even if the violation has been corrected prior to the time of the hearing.

After the hearing, the Code Enforcement Board or the Special Magistrate will make findings of facts, conclusions of law, and if a violation is found to have occurred, issue an order compelling a fine until compliance is met. Since this is your second violation on this property a \$500.00 per day for repeat violations, which, if assessed, could become a lien on your property depending on the out come of the hearing.

An aggrieved party may appeal a final administrative order of the Code Enforcement Board or the Special Magistrate to the circuit court. You must file any appeal within 30 days of the execution of the order to be appealed.
