It is alleged that you have failed to keep the pool in compliance, as required by the city code Sec. 18-37 therefore;

YOU ARE HEREBY NOTIFIED that on the 24th day of May, 2007 at 2:00 P.M., a hearing will be held before the Code Enforcement Board or Special Magistrate of the City of Treasure Island, Florida at City Hall, 120 108th Avenue, Treasure Island, FL 33706, at which time you may present evidence, call witnesses, cross-examine witnesses, and be represented by an attorney.

If you do not appear at the hearing, the hearing will proceed in your absence. Further, this case may still be presented to the Code Enforcement Board or Special Magistrate at the hearing even if the violation has been corrected prior to the time of the hearing.

After the hearing, the Code Enforcement Board or Special Magistrate will make findings of facts, conclusions of law, and if a violation is found to have occurred, issue an order compelling compliance. Failure to comply with an order of the Code Enforcement Board or Special Magistrate could result in a fine of up to \$500.00 per day for a second time violation which, if assessed, could become a lien on your property.

An aggrieved party may appeal a final administrative order of the Code Enforcement Board or Special Magistrate to the circuit court. You must file any appeal within 30 days of the execution of the order to be appealed.
