RENTAL FEES:

- Deposit \$100.00 deposit is required at time of contract. The deposit will be returned after the event provided there is no damage to facility or overtime over the initial, scheduled 6 hours or rule infractions.
- Resident or tax payer \$200.00 plus tax for a six-hour rental (during scheduled operational hours)
- Non-resident \$300.00 plus tax for a six-hour rental (during scheduled operational hours)
- Overtime Fee \$50.00 plus tax per hour after the initial six (6) hours
Overtime fees need to be paid in advance. Fees not paid in advance will be deducted from the security deposit should the event last longer than the initial, scheduled 6 hours

Rental of the Beach Pavilion includes 16 reserved parking spaces in the BLACK SKIMMER LOT. Non-reserved parking lots are adjacent to the Beach Pavilion at the Tern Lot, West Gulf Boulevard and 77th to 79th Avenue. Parking in the Tern Lot is on a first come, first serve basis. Recreation Department staff will distribute parking passes on the day of the event. **The parking passes are only valid for the day of the event and for a six (6) hour period beginning at the time specified on the contract.**

Parking Lot #2.5 (Black Skimmer Lot) \$25.00 plus tax for 3 hours; \$7.50 plus tax for each additional hour.
Lot is available only if Beach Pavilion is not rented.

Applications are to be submitted to the Recreation Department at 120 108th Avenue, upon reserving facility.

NO public address systems, bands or disc jockeys using amplified instruments or microphones will be permitted
