Stat. § 119.071(a), all bids submitted will be subject to review as public records thirty (30) days after bid opening, or earlier if an intended decision is reached before the thirty (30) day period expires, unless all bids are rejected and notice of intent to reissue is provided. Unless a specific exemption exists, all documents submitted will be released pursuant to a valid public records request.
